# Care home fees at Jewish Care

We will only ever be completely transparent about our fees. There are no hidden costs or surprises.

### How fees are determined

Our care home fees vary and are based on two factors:

- Which care home the resident lives in
- The type of care we provide to the resident

# The types of care we offer

Each care home offers at least one of the following care types.

### Residential care

Residential care (also known as personal care) is for people who need help with daily activities. This could include washing, getting dressed, eating and drinking, mobility, and interacting with others. It could also include help with taking medication, or support with a medical procedure performed by a community nurse.

### Dementia care

For people who require help with daily activities and routines because they are living with dementia. They may also have some additional care needs, such as support with communication, managing their mood and reducing feelings of confusion and anxiety.

# **Nursing care**

For people who have a condition that requires the supervision of nurses, that cannot be performed by a community nurse. They also need help with daily activities. They may need nursing support with taking medication, managing pain or another nursing procedure.

### Nursing with dementia care

For people living with dementia and who have a condition that requires the supervision of nurses. They also need help with daily activities. The nursing care needed cannot be performed by a community nurse. They may need nursing support with taking medication, managing pain or other nursing procedures.

### Mental health care

Mental health care is tailored to each person's unique needs. It provides a safe, supportive, but unobtrusive environment. Residents can develop or maintain their independence and daily living skills, with the option of support on hand.

### **End of life care**

End of life care (also known as palliative care) is the most sensitive personal service. We work alongside both the person in our care and the important people in their life. We make sure that everyone involved is informed and understands about end of life and palliative care. The person in our care receives any nursing support they need as well as all the information available to support their decision making. We help them navigate information and meet their cultural and spiritual needs.

### End of life with dementia care

End of life care for a person living with dementia may mean they have some additional care needs, such as support with communication, managing their mood and reducing feelings of confusion and anxiety.

# Respite care

Respite care (also known as a short-term stay) is subject to availability. It is for people who need care for a limited amount of time. This could be to recover from an illness, to try out a care home, to allow carers a break, or for peace of mind while the usual carers are not around for a period of time.

# Fees for permanent care

Permanent care means the resident lives in the care home on a permanent basis, with no specified end date.

The fees listed here apply until 31 March 2026. We review our fees every year and any changes take place from 1 April. We always give at least one months' notice of any fee changes.

### Additional one-to-one care

This is an additional fee on top of the advertised weekly fees for permanent and respite residents.

Some residents may require additional one-to-one care as a one off or for continued periods of time. We will explain, discuss and agree this with the resident and the funder before putting in place. It is a flexible arrangement that is reviewed regularly according to the resident's changing needs.

Examples of instances where a resident may require additional one-to-one care:

- They need accompanying to a hospital appointment.
- They have a high risk of falling or injuring themselves.
- They have symptoms that create risks to themselves or others in the home.

The one-to-one care fee is £25.22 per hour.

### What we include in our fees

### **Accommodation**

A private bedroom usually with en-suite shower room, plus communal spaces and lounges. Please check that your room has an en-suite if this is important to you.

### **Full board services**

All meals, snacks and drinks (including special diets) using kosher ingredients. Some of our care homes are under kosher licence, so please check with us beforehand if this is important to you. Cleaning, bed linen, and laundry (excluding dry cleaning) are also all included.

### Care

Personalised care and support according to the resident's individual needs. Our dedicated and well-trained carers and nurses provide this service every day and night of the year. This is overseen by the registered managers.

### Recreational activities

A rich programme of activities, events and outings. Our professional teams of activity co-ordinators and volunteers work with residents to deliver activities that suit a wide range of interests and abilities. Please note, there may be times when there is an additional cost in this area. We will always give choices, explain any costs, and give advance notice of these.

### **Jewish Way of Life**

The Jewish culture is interwoven into every aspect of life in our homes. All homes have Kiddush and a Shabbat Service, many attended by the community. We have an in-house Rabbi and come together to celebrate the Jewish festivals. In most cases we can also enable a Jewish burial by providing the necessary documents in a timely manner.

### Health

Three of our homes have nurses on site, while community nurses visit the rest on a regular basis. Each home is registered with a local GP practice that visits the home regularly, should you need an appointment.

### **Finances**

Support with managing a resident's personal expenses. Our homes' administrative staff will manage a resident's personal expenses account in a safe way, ensuring that statements are available on request.

### Services available for an additional fee

The following items and services are not included in the fees, but we can still arrange for them to be provided. We will always tell you how much they cost before you agree to pay for them.

- Personal items (e.g. clothes, toiletries and newspapers)
- Hairdressing
- Chiropody
- Medication, equipment and prescription charges
- Telephone line installation and service charges
- Television and subscriptions (unless you are a respite resident)
- Staff assistance and escorts for medical appointments and your private outings outside of the care home
- Special equipment not available in the home, such as bespoke recliner chairs, wheelchairs and medical aids
- Staff employed directly by you or your family as companions
- Additional staffing costs to provide one to one care, or other additional care over and above the standard level of care
- Meals and refreshments for visiting family and friends
- You may be asked to make a financial contribution to the cost of some special activities or excursions

# **Deposit**

## Deposit for permanent residents

Permanent self-funding residents pay a security deposit of one month's fees. Residents who are not self-funding are not required to pay a deposit.

The deposit is refunded without interest when the resident leaves. If necessary, deductions will be made to the amount returned to cover any damages, excessive wear and tear to the room, unpaid fees or other instances where our terms and conditions have not been met. It is also refunded if the resident is initially a self-funder and the funding changes to local authority or NHS funding.

# Deposit for respite residents

Respite residents do not pay a deposit. Instead, they pay their full fee for their entire stay upfront. If the resident later extends their stay, they pay the full fee for this extended period at the time of booking.

# How to fund a place in a care home

There are different ways to fund a place in a care home. These depend on the resident's (and sometimes the family's) financial circumstances. This section of the guide explains the different options:

- Self-funding
- Local authority funding (including family contribution)
- NHS funding (including continuing healthcare and NHS-funded nursing care)

# **Self-funding**

Self-funding is a way of paying for a place in a care home using your own savings, investments, and assets. You are a self-funding resident if:

- You have assets above the threshold of £23,250 (this threshold is set by the government).
- Or you have assets below £23,250 but you do not meet the care needs criteria set by the local authority.

Please note that you may be eligible for NHS funding even if your assets are above the threshold (see the NHS funding section for more information).

Self-funding residents pay their fees directly to Jewish Care through a direct debit. This payment takes place on the 15th of each month. We calculate the monthly cost according to the number of nights in the month.

If your savings decline and fall below the threshold of £23,250, you should tell us at least six months in advance if this is possible. In this circumstance you may be eligible for local authority funding.

# Local authority funding

Local authority funding is when your local council funds some or all of your place in a care home. You are eligible for this funding if:

- Your assets are no higher than the threshold of £23,250.
- You meet the care needs criteria set by the local authority.

To access this funding pathway, you will need to apply to your local authority. They will send you their financial assessment paperwork which you will need to complete and return to them as soon as possible. Once they have reviewed the assessment and confirmed you are financially eligible for local authority funding, they will agree a start date in principle which is then subject to a care needs assessment by an allocated local authority social worker. The financial assessment, together with the social work assessment are presented to a panel for funding approval.

If you own a property, this will be taken into account. There are some circumstances where they may disregard the value of your property, such as if your spouse or partner still lives there or a dependent over the age of 60.

Once they agree funding, they will confirm this with Jewish Care. The council will then carry out regular reviews of your care plan and care home placement, to make sure you receive appropriate care and support.

# **Client contribution**

When the local authority funds your care home placement, they require you to pay a 'client contribution'. This is a regular payment you make towards the cost of your care. They decide how much you need to contribute based on your financial situation.

The calculation will use some of your income, like pensions, to help cover the cost of your care. However, you will always have a Personal Expenses Allowance of at least £30.65 per week remaining. Depending on your specific situation, the local authority may increase this amount.

# Family contribution (also known as third party top-up)

With local authority funding there is a significant shortfall between the amount the local authority fund and the actual cost of care. Local authorities only pay on average about half of what the care home placement costs. A 'family contribution' is a financial contribution we ask from the resident's family (usually their children) to help us bridge this gap. Only by doing this can we continue to keep the doors of our care homes open. We will never approach a resident or their spouse to pay this contribution.

# **NHS funding**

NHS funding is when the NHS funds some or all of your place in a care home. This is based on your healthcare needs and not on the value of your assets. There are two types of NHS funding:

- NHS-funded nursing care
- NHS continuing healthcare

# NHS-funded nursing care

This is when the NHS pays towards the nursing care component of a resident's care home fees. The NHS pays a flat rate directly to Jewish Care. Jewish Care then refunds this amount to self-funding residents who have already paid for the nursing element of their care.

You may be eligible for NHS-funded nursing care if:

- You are not eligible for NHS continuing healthcare but have been assessed as needing care from a registered nurse.
- You receive nursing care in a care home.

You should have an assessment for NHS continuing healthcare before a decision is made about whether you are eligible for this.

NHS-funded nursing care is paid at the same rate across England. This funding is available until you no longer have nursing needs, or you become entitled to NHS continuing healthcare instead.

# NHS continuing healthcare

NHS continuing healthcare is the name given to a full package of care that the NHS arranges and funds. This is a way to pay for a care home place if you have complex healthcare needs, requiring ongoing nursing care and support. It is not for people who need to be in hospital.

Having a disability or a long-term health condition does not mean you are automatically eligible for this funding. The NHS team carries out an assessment to determine eligibility. They look at your care needs, medical history, and any details relating to your health condition. The assessment process can be complex, so it may be helpful to get help from an independent advocate to navigate the process.

If you meet the eligibility criteria, the NHS will pay your care home fees. The funding covers the cost of your accommodation, meals, care. They also fund any other support services you need because of your health condition.

# NHS continuing healthcare: End of life care

If a resident's health is deteriorating quickly and they are nearing the end of their life, they should be considered for the NHS continuing healthcare fast-track pathway. This allows for an appropriate care and support package to be put in place as soon as possible - usually within 48 hours.
